Rationale

After the transition-dominated 1990s, the issues of growth and development are back on the research and policy agenda for the Central and East European countries. Within this new – old agenda, the knowledge and restructuring of the CEECs towards knowledge-based economies has become one of the key concerns of researchers and policy makers.

At a time when the European Union has given itself the objective of becoming the most knowledge-based economy in the world, the issues of knowledge based growth in CEECs have become even more important. Will the accession facilitate this shift or will CEECs become a liability to this objective?

Based on the rationale, the conference aims to address three key issues:

- How the transformation of CEECs during the 1990s has affected knowledge-based activities, in particular software, electronics and other information and communication technology sectors.
- How the economic integration of East and West has affected the knowledge-based sectors and whether it will shift CEECs towards or away from knowledge-based activities.
- 3. Will CEECs be able to transform their economies towards the knowledge-based economy given their inherited but obsolete and newly acquired technological and human assets?

Thematic scope

- The knowledge-based economy in CEE-measurement issues: results and methodologies in the areas of:
 - · innovation surveys,
 - patents,
 - · ICTs diffusion,
 - R&D,
 - · knowledge management in enterprises,
 - vocational training,
 - e-learning,
 - e-economy.
- ICT and restructuring of CEECs: empirical contributions, which analyse suppliers' and users' ICT sectors in CEE from the perspective of growth and restructuring, especially:
 - software,
 - electronics,
 - · internet,
 - · telecommunication.
- 3. Social and economic determinants of digitalisation of CEE: contributions, which:
 - assess the diffusion of ICTs,
 - their use and determinants,
 - social and business absorption of ICTs.
- 4. Research & Development in CEE: empirical contributions, which consider:
 - · the state of R&D systems and
 - their capacity to meet requirements of knowledge based growth.
- Policy issues arising from a knowledge-based growth agenda: an inventory of current policy practices in areas of:
 - competition,
 - innovation,

- April, 10 submission of complete papers prepared according to editorial guidelines

Editorial guidelines

The conference will be in London and papers are expected to be presented in English only. SSEES reserves the right to edit any papers before publication.

The papers should be:

• up to 8 000 words as Word file,

- · with abstract, key words,
- · with full English style references,
- information about the author in the left-hand corner of the first page,
- references in the text should refer to the name and date of publication,
- you are requested to provide pictures, graphs in separate, original files, if possible.

Venue

The conference will be conducted in central London, at the University College London. A map of the location will be provided later.
